## BCO Code of Ethics (for breeders)

- My goal in breeding Bulldogs will be to improve the breed, and according to the Breed Standard.
- I will not deliberately breed Bulldogs in colours that are considered disqualifying according to accepted world breed standards ie: CKC, AKC, KC, FCI. If such a colour is inadvertently produced in my litters, it will be spayed/neutered and sold as a pet only, to an approved home. It will NOT be represented as a rare, exotic, unusual, or unique colour commanding a higher price tag.
- I will refuse to provide stud service to any bitch that lacks the quality to produce sound, healthy pups that meet the breed standard in all regards. This would be contrary to breed improvement (#1).
- I will sell on a spay/neuter contract any dog which has faults which would be detrimental to the breed, I will ensure that each of my dogs is properly registered with the Canadian Club or other accepted registration organization and further, if I breed a litter, each puppy sold will be individually registered.
- I will not engage in the sale or resale of any Bulldogs, other than those owned, co-owned or bred by myself.
- I will test all breeding stock in my breeding program for any known genetic defects which afflict my breed, and will willingly share results of such testing when required.
- I will protect an agreement with another breeder or persons by having all paperwork prepared in duplicate and signed and understood by both parties, with each party retaining a copy.
- I will respond promptly to any written complaint or other query regarding a dog sold by me. And I will be honest and forthright in my assessment.
- I will not sell or donate dogs to commercial dog wholesalers or retailers (puppy mills or pet shops) nor to those that do so.
- I will maintain high standards in the care of my dogs and will comply with all Canadian Kennel Club regulations, rules, code of practice and code of ethics. [www.ckc.ca](http://www.ckc.ca)
- I will support in all ways possible, the new owner of one of my Bulldogs, for the entire life of the dog.
- I will not degrade other breeders, other dogs or other breeding programs. If I have reservations about them, my refusal to comment will be sufficient.
- I will endeavour to conduct myself at all times in a manner that will reflect favourably on my breed, those who have entrusted me with their dogs, and on the sport of purebred dogs in general.

By signing this membership application, you agree to abide by the bylaws of this club, and breed Bulldogs only according to the accepted breed standard. You further will never cross breed your dogs, and will always adhere to the principles of good sportsmanship, proper conduct and decorum when displaying and promoting the Bulldog. A member shall not make or cause to be made any statement or commit or cause to be committed any act which in the reasonable view of the BCO is likely to bring into disrepute the credibility of the club or sport of purebred dogs. The club and its executive reserves the right to terminate a membership at any time that its bylaws or code of ethics are contravened.
